

SUGGESTIONS:

1. Separate department for Botany and Human Physiology are required.
2. Number of full time/ regular teacher in the department of Zoology, Botany and Physiology should be increased, i.e. at least 4 regular teachers in each Dept.
3. Laboratory infrastructures and facilities are not up to the mark for Botany because there is only one common laboratory for Zoology, Botany and Human Physiology.
4. The Science departments should be shifted to the new campus very soon extending all the infrastructure facilities to Bioscience department.
5. Subscription for some of Bioscience Journals (Botany, Zoology and Human Physiology) to cater to the need of students is necessary.
6. Laboratory technical assistant/attendant should be engaged.
7. There is acute shortage of faculty for the BBA programme, it is suggested to appoint faculties for all the specialised subjects maintaining UGC norms.
8. Books available in the library for BBA programme are not adequate, so it is suggested that college authority should purchase books both for common and specialisation papers for BBA programme.

RECOMMENDATION:

Considering all the above observations and suggestions, the committee recommends that Permanent Affiliation may be granted to Holy Cross College, Durjoynagar from the academic session 2015-2016. However, the college authority be requested to comply with the suggestions stated above and will send one Compliance report to the University.
