Holy Cross College, Agartala: Holy Cross College, Jubatara, Lembucherra, Agartala, West Tripura, India and **ICFAI University, Kamalghat, Mohanpur, West Tripura, India** a formal Memorandum of Understanding is made between Holy Cross College (hereinafter referred to as "HCC") represented by **Dr. Fr. Benny K. John, CSC Principal, Holy Cross College Agartala**, which expression shall unless repugnant to the context or meaning thereof, be deemed to include its successors, legal representative and permitted assigns;

AND

The ICFAI University, Tripura: a University established under Section 4(2) of The Institute of Chartered Financial Analysts of India University Tripura Act of 2004, enacted by the State of Tripura, having its Campus at Village Kamalghat under Mohanpur Sub Division in West Tripura district-799210 (hereinafter called as "IUT"), represented by **Registrar Dr. A Ranganath**, which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns.

Holy Cross College and IUT are independently referred to as 'party, and collectively as "parties". The parties agree to engage into broad spectrum of joint activities in the fields of promotion of educational programmes, Research Activity, Faculty & Student Exchange, Training programmes, SME Business Development and Sustainable Livelihood Promotion in the North -Eastern part of India. This MoU shall be treated as the guidelines on which both parties agree to work together in future. The terms and conditions of this MoU are mentioned in following para:

1. BACKGROUND

Holy Cross College is a private English medium Catholic institution of higher learning founded, animated and enlivened by the Congregation of Holy Cross, a community of scholarship and faith, anchored by a belief in the Inherent dignity of each person. This institution provides opportunities of scholarship for academically qualified high school graduates predominantly from the state of Tripura and the north-eastern region of India. It is a to - educational institution of higher learning in the traditions of the Congregation of Holy Cross with a clear focus on 'holistic education', educating the hearts and minds of the young.

University is committed to provide students all possible opportunities to acquaint them with modern techniques and encourages them to conduct research activities.

2. PURPOSE & SCOPE

In contemplation of the relationship to be established and for consideration, parties agree as follows:

1. This MOU is not considered to be a contract creating legal and financial obligations between HCC and IUT. This MOU is designed to facilitate and develop genuine and mutually beneficial study programs, research relationships, and exchange programs. It is agreed that HCC and IUT will work together to promote the following:
 - a. Student and Faculty exchanges
 - b. Sharing of library resources based on terms and conditions
 - c. Curriculum development and sharing of information
 - d. Exchange of academic information including Research
 - e. Collaborative research in any field of interest common to both institutions
 - f. Creation and organization of conferences
 - g. Cultural exchanges and other activities to increase cultural links and mutual understanding between HCC and IUT.

3. OUTLINE OF COLLABORATION

Under the aegis of this MOU, the parties shall jointly explore the possibilities of working mainly in the North Eastern part of India. The broad areas of cooperation would include the following:-

- a. Designing viable and feasible roadmap for joint activities;
- b. Taking up studies and action research projects on socioeconomic analysis, livelihood security, market intelligence, value chain and other areas of research in NE region of the country ;
- c. Mutual help in promoting placement of the students of both the institutions in the private sector.
- d. Planning and organizing seminar, conference, workshop, training and capacity building programmes in the domains of entrepreneurship, livelihood promotion, new enterprise creation and cluster development and other common area of specialization of both the institutions.
- e. Based on specialty in the field, cooperation among the faculties of both institutions for carrying out research in various programmes.
- f. Undertake joint activities in rural areas under national flagship programmes like Mera Gaon Mera Gaurav, Swachh Bharat Abhiyan, Unnat Bharat Abhiyan etc and other central & State Government projects.
