



MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

HOLY CROSS COLLEGE (HCC), AGARTALA

AND

LADY BRABOURNE COLLEGE (LBC), KOLKATA

PREAMBLE

Holy Cross College, Jubatara, Lembucherra, Agartala, West Tripura, India and Lady Brabourne College, Kolkata, India after their communications and a number of collaborations, have agreed to sign on a formal Memorandum of Understanding. HCC and LBC desire to establish certain cooperative programs among the Department of Political Science of both the institutions. This will be beneficial to both the educational institutions. Through this collaboration, we wish to promote the development of studies, field visits, research, student and teacher exchanges, and other collaborative educational programs of mutual interest.

AGREEMENT

In contemplation of the relationship to be established and for consideration, parties agree as follows:

- 1. This Agreement replaces any and all previous agreements between the parties. Subsequent discussions, agreements and understandings, whether verbal or in writing, are subsumed by this Agreement. Any changes required will be in the form of written agreement between both the institutions.
- 2. This Agreement is not considered to be a contract creating legal and financial obligations between HCC and LBC. This Agreement is designed to facilitate and develop genuine and mutually beneficial study programs, research relationships, and exchange programs.
- 3. It is agreed that the Department of Political Science, HCC and the Department of Political Science, LBC will work together to promote the following:
 - a. Students' Exchanges and visits
 - b. Teachers exchange programs and invited lectures
 - c. Seminars, workshops and conferences
 - d. Exchange of information for Academic and Research purpose (with terms and conditions)
- 4. This Agreement will incorporate and provide the foundation and framework for particular academic and research programs.
- 5. This Agreement, when executed by the parties, shall continue for a period of five years starting from the day of signing on it. Upon written agreement by both the parties, this Agreement may be renewed for an additional period of time with notification at least six (6) months before expiration of the agreement. Either party may terminate the Agreement with six (6) months' written notice of intent to terminate the same
- 6 No implementation of any portion of this Agreement or commencement of any specific projects may be initiated prior to the written assurance of adequate budgetary resources. HCC and LBC may jointly or individually seek funding and other support from third parties to support activities under this Agreement.
- 7. This Agreement shall not be construed to create a relationship of partners, brokers, employees, servants, joint ventures or agents as between the parties. The parties to this Agreement are acting as independent participants. In the event that the parties decide to engage in activities which involve employment, separate agreements addressing those issues will be required.
- 8. The parties shall cooperate mutually to resolve any dispute or misunderstanding by collaboration and discussion.

- 9. Either party shall have the absolute right to terminate this Agreement with or without cause upon six (6) months' prior written notice to the other party.
 - 10. This Agreement shall be considered in effect upon the signatures of all required representatives of each institution.
